Items to be removed from the consent agenda:

Presiding Commissioner Morris entertained a motion to approve the consent agenda, which included Christian County Commission's agenda for today December 04, 2025, as posted; one financial, Certified Commission Order no. 12-04-2025-01; there are no minutes to address. Western Commissioner Williams so moved. Eastern Commissioner Jackson seconded the motion.

The Commission met with Treasurer Melissa Bilyeu for an amendment to the Tyler Tech rapid financial court fund. The amendment is due to a price increase; the financial court fund is for debit cards issued for those who serve jury duty. Discussion was held.

Presiding Commissioner Morris entertained a motion to approve the Tyler Tech Rapid Financial Court Fund Amendment as presented. Western Commissioner Williams so moved. Eastern Commissioner Jackson seconded the motion.

The Commission met with Christian County Ambulance District Director Christie Thompson to discuss renewal of the AEDs in County buildings. Director Thompson noted that the current AEDs were purchased with a cost-share agreement between CCAD and the County, now all 10 AEDs need to be replaced. The quote provided by Stryker is for \$14,328.90; The County will only be responsible for half the quoted amount, \$7,164.45.

Director Thompson also noted that when the new AEDs are to be installed, she will personally go through each building with a staff member to ensure they are properly located. Additionally, CCAD will offer education at no cost to ensure they are properly operated. Discussion was held.

Presiding Commissioner Morris entertained a motion to agree to cover half the cost to replace all 10 AEDs as presented, adding that 2 preferably be placed in the Historic Courthouse. Eastern Commissioner Jackson so moved. Western Commissioner Williams seconded the motion.

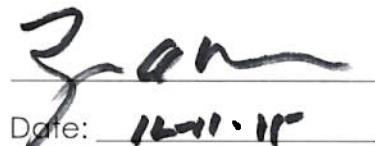

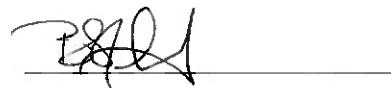
