Items to be removed from the consent agenda:

Presiding Commissioner Morris entertained a motion to approve the consent agenda, which included Christian County Commission's emergency agenda for today December 12, 2025, as posted; there are no minutes or financials to address. Eastern Commissioner Jackson so moved. Presiding Commissioner Morris seconded the motion.

The Commission met with Auditor Amy Dent, Treasurer Melissa Bilyeu and Employee Services Director Amber Bryant for approval to open a new bank account. As the County is becoming self-insured for medical benefits, it requires a separate account to be opened. As it is already December the account must be opened as soon as possible to pay associated fees within the next 2 weeks. The initial deposit for the account will be a transfer from General Revenue, as funds collected from payroll will not be deposited until the week of January 9, 2026 (1st payroll of 2026); the amount transferred from General Revenue will be repaid. This account will be titled Christian County Government Group Claims Account, assigned as Fund 800; and will have two signers, Treasurer Melissa Bilyeu and Auditor Amy Dent. Discussion was held.

Presiding Commissioner Morris entertained a motion approving the opening of a new bank account, titled Christian County Government Group Claims Account. Eastern Commissioner Jackson so moved. Western Commissioner Williams seconded the motion.




