

This Amendment No. 3 is entered into by and between the **State of Missouri, Office of Administration** (hereinafter referred to as “**State of Missouri**” or “**Customer**”) and **Environmental Systems Research Institute, Inc.** (hereinafter referred to as “**Esri**”).

WHEREAS, Esri and State of Missouri entered into a Master Purchase Agreement with an effective date of February 1, 2025 (hereinafter “**Agreement**”); and

WHEREAS, the parties desire to amend the Agreement to extend the term.

NOW THEREFORE, the parties agree to the following:
