The Commission met with Resource Management Director Todd Wiesehan for the 4th Quarter and Year End Report. Discussion was held; no action was taken.


The Commission met to read and approve a Resolution for the Mark Twain National Forest. Presiding Commissioner Morris read the resolution aloud and discussion was held.


