
The Commission met for the Christian County Library Board of Trustees appointments. Currently there are two open positions; South County (townships of: North Galloway, South Galloway, Saddlebrooke, North Linn & South Linn); and Nixa Area (townships of: Union Chapel, Northview, Rosedale and Garden Grove). South County's current board member resigned as she no longer resides in the designated township area (Echo Schneider), and the Nixa Area position has an expired term. The Commission only received 4 applicants (Ashley Popejoy, David Rice, Echo Schneider, and Koleman Parsley) for the two open positions, none of which reside in the South County area. Per the Commission, they may appoint outside of the township areas, despite it being in the bylaws of the Board of Trustees. The Commission voted, Echo Schneider and Koleman Parsley were selected as the two newest board members.

Presiding Commissioner Morris entertained a motion affirming the appointment of Echo Schneider, and Koleman Parsley to the Christian County Library Board of Trustees. Eastern Commissioner Jackson so moved. Western Commissioner Williams seconded the motion.


The Commission met briefly for communications.

The meeting was adjourned at 9:52 a.m.




