The Commission met with Show Me Christian County as they presented a service award to Todd Wiesehan. Discussion was held; no action was taken.

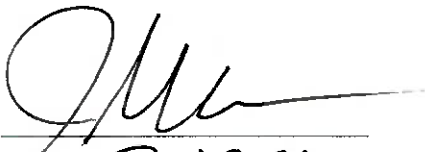
The Commission met with Purchasing Manager Kim Hopkins-Will for renewal of ITB #2022-9 Commercial Real Estate Services. Discussion was held.

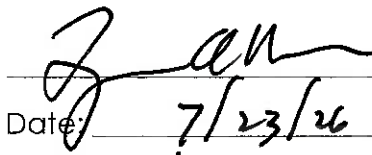
The Commission met briefly for communications.

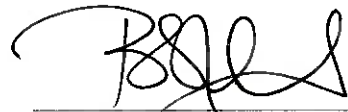
