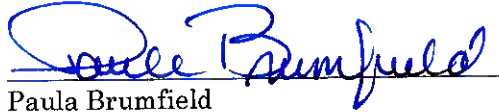
The current number of registered voters for Christian County is 67,806. The breakout of voters by polling location is as follows:
