Christian County Commission Minutes November 20, 2025

SUBJECT: Call Election: Billings Special Road District Tax Levy

Commissioner _____ moved that the County Commission of the County of Christian accept a petition which reads to wit:

We, the undersigned, resident qualified voters and taxpayers of Billings Special Road District, in Christian County, Missouri, hereby petition the county court of Christian County, Missouri, to call a Special Election within and for said road district for the purpose of Submitting to the qualified voters of said road district the proposition of voting for or against to continue a special tax levy of thirty-five cents (0.35) on the one hundred dollar (\$100) assessed valuation of said road District, for general road purposes in the said district. Said Special Levy to be in excess of regular tax levy for road purposes levied by the County Court, and to be voted for a period of four years.

Said Commission also accepts from the County Clerk and Election Authority of Christian County the following certification:

In that said Petition meets the requirements set forth in Chapter 137.565, RSMo., the County Commission hereby Orders an election to be held in the Billings Special Road District and conducted by the County Clerk on Tuesday, the 7th day of April, 2026, in accordance with the provisions of Chapter 115 RSMo.

Be it further Ordered that the Commission adopts the Notice of Election and Sample Ballot to be printed in substantially the following form:

Notice is hereby given to the qualified voters of the billings Special Road District that the County Commission of the County of Christian has called an election to be held in said District on Tuesday, the 7th day of April, 2026, between the hours of six o'clock a.m. and seven o'clock p.m. on said day for the purpose of voting on continuing the special tax levy of thirty-five cents (0.35) on the \$100.00 assessed valuation as finally equalized for a period of four (4) years.
